

Exemption from provisions of Health and Safety at Work (Asbestos) Regulations:

In accordance with section 220 of the Health and Safety at Work Act 2015 (the Act), I, Gordon MacDonald, Chief Executive, exempt Antarctic Heritage Trust from compliance with the following provision(s) of the Health and Safety at Work (Asbestos) Regulations:

> Regulation 41(2)(a) Regulation 43(1) Regulation 46(6)

I do so -

- being satisfied that:
 - the extent of the exemption is not broader than is reasonably necessary to address the matters that gave rise to it.
 - the exemption is not inconsistent with the purpose of the Act.
 - The persons undertaking the asbestos removal and clearance monitoring work are fully competent to do so and work will be carried out to the required standard using the required methodology and equipment.
- subject to the following conditions (also detailed in Appendix A):
 - The person commissioning the work must comply with their duties in regulations 41, 43 and 46 as if Mr Hindle were a licenced asbestos assessor.
 - The person undertaking the air monitoring and clearance testing is competent to undertake these tasks
 - Results of the clearance testing are to be provided to Richard Steel, CAR Team Leader, within 20 working days of completion of the asbestos removal.
