# Agenda was tabled, venue housekeeping and emergency procedures outlined

# Chair welcomed all attending. Dr Chris Sames' paper on Audiometry and Respiratory Testing for Occupational Divers has been successfully critiqued and is no ready to be published (cf. SPUMS Journal). Chair noted that two other papers in Europe appear to follow the finding of the local study.

Chair advised that DHMS had finished a study on what applicants think about the Medical Clearance process – 80% happy with system, 15% unhappy with monitoring regime. 90% of the negative feedback appears simply opposed to any system, though many suggest annual medicals preferable at an even high cost). Chair outlined that NZ has the only single system that monitors occupational divers.

## # Technical Bulletins -

- DIAG's "Divers' Hose" approved for sending to WorkSafe Guidance and Comms.
- Powered Tools Working Group drafting notice. Power, job and control systems being discussed.
- Oxygen Partial Pressure to be reviewed by Working Group and circulated to members for approval.
- # Clarification between Surface Snorkelling (no weight belt) and breath-hold diving/ freediving (with a weight belt) to be included in the DRAFT Guidelines.
- # Medical Requirements for Snorkellers & Freedivers was discussed. Chair recommended centralised medical system as most freediving fatalities have identifiable medical issues. To be included in new CoC Project or Guidelines.
- # DIAG Facebook Page remains in discussion with WorkSafe Comms to close & remove. Redirection post to DIAG web page added.
- # DIAG Web Page up and running on WorkSafe site. Members to visit WorkSafe Occ Diving web pages and provide feedback.
- # CoCs for Construction Diver Supervisors Not possible under current Regulations. Possible when new Regs are considered (maybe late 2020?). Most important criteria is for industry to understand the requirements for someone to act as a Dive Supervisor.
- # Conditional Medical Clearances Confirmed as now in use with CoCs. Cards & letters will read: VALID ONLY WITH CURRENT MEDICAL CLEARANCE then the second line to have the option:
- NO CONDITIONS APPLY, CHECK DATE (or) CONDITIONS APPLY. REFER TO CERTIFICATE.
- # Health Based Diving Standards Awaiting DRAFT from Guidance and Education. DIAG to review to assess need for further Health Based Controls.
- # Continuing Professional Development for CoCs example of DRAFT requirements circulated. Each sector to offer ideas on how to deal with CPD.

# Waiver for on-site chamber Update. Chair indicated that this could be a repeated if successful. DIAG advised that the practice has been completed and awaiting report.

## 2 minutes silence was held in remembrance of the Christchurch terror attacks

- # SSBA Part 3 Currency & CoC Renewal requirements to be moved to New CoC Project.
- # DRAFT Risk Model for Occupational Diving Updated to include Job Classifications received from Sectors.
- # WorkSafe Guidelines Review Project update awaiting Guidance and Education to release DRAFT to DIAG and Working Group
- # WorkSafe Guide to Gas Cylinders update awaiting Guidance and Education to release final version on website.
- # SF17 Standards Committee status was discussed. Awaiting outcome of 2299.2 and 2815.6 DRAFTS.
- # Minimum requirements for Standby Divers Discussion on wording submitted by SubSea and whether SSBA standby divers should be using SCUBA. Concerns were raised regarding impact across sectors. Working Group to draft wording.
- # Film & Media CoCs Sector Job Classifications included in Risk Model. Film & Media CoC to be specific to Film & Media industry.
- # Proposed Changes to Occupational Diving Medical Discussion on proposed changes to the Audiometry and Spirometry Test requirements post Chris Sames paper. DIAG supportive.
- # HSWA & Regulatory Presentations for Sectors WorkSafe Comms have approved Sector and Industry PPTs to outline HSWA, Regulations & Guidelines. WorkSafe to edit and send to sectors for use in training and at conferences.
- # Occ Diving Newsletter WorkSafe Comms have approved an Occupational Diving Industry Newsletter that will be sent to those who "sign up". Initial version will sent with sign up option. WorkSafe will be asking DIAG members to spread the word. 1<sup>st</sup> one hopefully out early July.
  - The issue of "urgent industry communication" was discussed. An example of a recent
    incident in Tauranga whereby hyperbaric treatment was delayed resulting in long term
    spinal injury. WorkSafe advised that such and issue is most likely best managed as a "Safety
    Alert".
- # Audits & site visits WorkSafe CAR will be auditing occupational dive business to compliance to Regulations (CoCs, etc) and good practice starting from July 2019 involving both desktop and site visits.
- # Recent On-site Observation WorkSafe CAR Team was recently invited to observe diving operations at a major port. Successful visit reflects improving industry acceptance of WorkSafe as an asset.

- # Notification of Diving Hyperbaric events Discussion on WorkSafe/DIAG seeking notification of Diving Hyperbaric events from the Chambers to determine whether a workplace was involved. Privacy issues were raised. WorkSafe to liaise with Chair on options.
- # Science Diving Stats for 2018 were outlined relating to the number of dives & divers. Chair thanked sector for feedback.
- # Divers Attendant Course & requirements Held over to next meeting as Shane not present.
- # Notifiable Works for Diving Held over to next meeting as Shane not present.
- #: Member Elections Stability and positive situation with current DIAG membership discussed. TOR to be updated to have Industry Sectors to decide whether to call elections for their representative. DIAG still to retain right of refusal if nominee unacceptable.
- # Next Meeting to include feedback from Chris Sames on Medical/CoC process and to be held in Auckland in July.
- # General discussion Aquaculture Diving Guidelines to be raised by email and to advise Chair on outcome.
- # Meeting closed at 2:15pm.
- # Invited Presentation from Snr Sgt Bruce Adams Possible lessons from Diving Fatalities.
  - Since 2006 there have been 70 diving fatalities (incl. 17 freediving ones). Coroners do not pass the finding on to industry or Worksafe.
    - o 60 had no occupational aspect, 6 involved recreational facilities (PCBUs).
    - o 41 had air quality not within standards
    - o 5 had cylinders not filled by approved fillers
  - Currently another 10 in progress (incl. 3 freediving ones)
  - Bruce to give PPT outline at next meeting.
